
State Context: An Act creating a Next Generation Roadmap for MA Climate Policy

- GHG target of net zero by 2050 and 50% by 2030
- Increase in clean energy
- Environmental Justice
- New appliance efficiency standards for residential and commercial products
- New opt-in net zero stretch code to municipalities
- Amends the Board of Building Regulations and Standards mission
- Dept of Public Utilities mission changed to include climate change and GHG emissions
- Mass Save incentives shift to energy efficiency and electrification
- Funding for green energy jobs at MassCEC


- Improves gas pipeline safety
- Established pilot program to deploy geothermal heat pump microdistricts


State Context: 2030 Clean Energy and Climate Plan (CECP)


- Commonwealth's 2050 Decarbonization Roadmap identified the need for:
 - Balanced clean energy portfolio with significant offshore wind
 - More interstate transmission
 - Widespread electrification of transportation and building heat
- 2030 CECP includes policy proposals for buildings, mobility, energy, land, waste, and agriculture to reach carbon targets
- The 2030 CECP is being reviewed to align with the targets set in the Next Generation Roadmap bill

Equity

Other Terms


Equality

Diverse groups have access within the community




